

Arctic Village Mission Church

The mission church in Arctic Village has applied for a National Trust for Historic Preservation's Preservation Services Fund (PSF). The purpose of the grant application is to perform a building assessment of the church in anticipation of its restoration for use as a cultural center/information center.

Most of Arctic Village residents claim kinship with the Neets'aii Gwitch'in, one of nine Gwitch'in bands of Athabascan Indians who traditionally occupied northeastern Alaska and northwestern Canada. The first permanent buildings in Arctic Village were built in 1909, although Neets'aii Gwitch'in lifestyles remained primarily nomadic for many years. Arctic Village did not function as a year-round settlement until 1959

when the first permanent school was built there. The Episcopal Church, however, has been an important element in community life since the village's earliest beginnings, due largely to the efforts and teachings of Albert E. Tritt.

Through contact with Episcopal missionaries during visits to Fort Yukon, Albert Tritt began to convert his neighbors in Arctic Village to the Episcopal creed. During the latter part of the first decade of the 1900s, Tritt held services in his own home for his immediate family and friends. By 1916 or 1917, Tritt and his followers were able to construct the major room of the Arctic Village mission church. Over the years, a bell tower was added to the front of the church along with a small addition to the back.

In 1925 Albert Tritt was ordained as a deacon in the Episcopal Church and continued to serve his congregation until his death in the mid-1950s. The church built by Albert Tritt remained as the community's church and social hall until 1960 when a new church was built. The original church has remained vacant since that time.

The Arctic Village mission church was listed in the National Register of Historic Places in April 1977, in part for its association with Albert Tritt. Its listing is also based on its unique logbuilding architectural style.

Over the years the church has deteriorated to the point where its continued existence is now threatened. In the late 1980s restoration of the building was considered under an economic development program. The restoration never materialized. The Arctic Village Mission Church was listed by AAHP as one of the Ten Endangered Historic Properties in 1991 and 1992. AAHP supports the efforts underway to work towards bringing this building back to life.

Alaska Office of History and Archaeology Offers HPF Development Grants

The Alaska Office of History and Archaeology is soliciting for Historic Preservation Fund predevelopment and development grant applications. The deadline to apply is February 15, 2002.

The intent of the program is to provide assistance to owners of National Register of Historic Places properties to ensure continued use and integrity of the property; stimulate economic development through heritage tourism; and increase public awareness and appreciation of Alaska's heritage. Qualifying properties are Alaska buildings or structures listed individually in the National Register of Historic Places or as contributing to a historic district listed in the Register, or properties determined eligible by the Alaska Historical Commission and the State Historic Preservation Officer.

The grants are reimbursable and matching. Federal funds are not eligible as matching funds. The grants are limited to a minimum of \$5,000 and a maximum of \$50,000 federal share. Individuals, businesses, corporations, nonprofit or for-profit organizations, local governments, and state agencies may apply.
